Based upon the student’s disciplinary infractions and/or severity of a specific situation, the administration reserves the right to modify the Code of Conduct. Students in grades 7 - 12 may be considered for enrollment in the Twilight Program when the Administration has determined the current academic day program is not meeting the needs of the student as the student would benefit from either an alternative learning environment or a significant increase in school counseling opportunities.

All infractions at all levels below will be logged into the Discipline Module of Real Time. Parents will have access to review infractions in the Parent Portal at any time. Infractions will be logged in within 24 hours of the incident.
