## 1. Unacceptable language, gestures, disrespectful comments or ethnic remarks towards students:

1<sup>st</sup> Offense: Teacher Responsibility & Parent Contact

2<sup>nd</sup> Offense: Referral to Guidance (Possible HIB) & Parent Contact

3<sup>rd</sup> Offense: Principal, Student & Parent Conference

4<sup>th</sup> Offense: Detention/Suspension

## 2. Cutting Detention:

Teacher: Teacher Responsibility & Parent Contact Administrative: Administrative Discretion & Parent Contact

#### 3. Unacceptable language, gestures, disrespectful comments or ethnic remarks towards staff:

1<sup>st</sup> Offense: Teacher Responsibility & Parent Contact

2<sup>nd</sup> Offense: Referral to Guidance (Possible HIB) & Parent Contact

3<sup>rd</sup> Offense: Principal, Student & Parent Conference

4<sup>th</sup> Offense: Detention/Suspension

## 4. Possession or use of tobacco products and/or matches, lighter, etc.:

1<sup>st</sup> Offense: Counselor-Student Conference

2<sup>nd</sup> Offense: Principal Conference

3<sup>rd</sup> Offense: Suspension

## 5. Possession of or under the influence of drugs or alcohol:

Principal Conference & Referral to SAC, as appropriate

# 6. Fighting (As defined by NJ Safety Data System Guidelines) - K-2 Out of School suspension in accordance to State Regulations\*

1st Offense: Principal, Student, Parent Conference & Up to 3 days suspension

2<sup>nd</sup> Offense: Principal, Student, Parent Conference & Up to 3 days suspension

3<sup>rd</sup> Offense: Principal, Student, Parent Conference & Up to 4 days suspension IST Referral, if appropriate

# 7. Assault on Staff

1st Offense: Admin. Discretion with up to 4 days suspension

2<sup>nd</sup> Offense: Admin. Discretion with up to 4 days suspension & possible IST Referral, if appropriate

#### 8. **Possession of a Weapon or Facsimile:** (Administrative Discretion based on type of weapon)

1<sup>st</sup> Offense: Police Contact & Up to 4 days suspension

2<sup>nd</sup> Offense: Police Contact & Up to 4 days suspension (Pending referral to Superintendent Hearing)

#### 9. Threat with a Weapon:

1<sup>st</sup> Offense: Police Contact & up to 4 days suspension (Pending referral to Superintendent Hearing)

## 10. Purposeful damage to School/Personal Property:

Offense: Principal, Student & Parent Conference & Restitution

#### **11. Stealing:** (Referral to police if warranted)

1<sup>st</sup> Offense: Principal, Student & Parent Conference & Restitution

2<sup>nd</sup> Offense: Principal, Student & Parent Conference, Restitution & Admin. Discretion (up to 3 days suspension)

3<sup>rd</sup> Offense: Principal, Student & Parent Conference, Restitution, Counselor Referral & Admin. Discretion (up to 4 days suspension)

#### 12. Harassment/Intimidation/Bullying:

Refer to the district HIB policy

Infractions will be addressed via Student Code of Conduct & level of discipline based on severity of infraction

#### 13. Arson/False Alarm:

1<sup>st</sup> Offense: Parent Contact, Up to 3 days suspension & Notification of appropriate authorities

2<sup>nd</sup> Offense: Parent Contact, Up to 4 days suspension, Pending referral to Superintendent & Notification appropriate authorities

#### 14. Truancy and Excessive Absenteeism

Up to 4 days of Unexcused Absences: Teacher/Counselor Responsibility & Parent Contact

Between 5-9 days of Unexcused Ubsences: Attendance Plan created by Counselor

10+ days of Unexcused Absences: Truancy Court Appearance

## 15. Leaving grounds without permission

1<sup>st</sup> Offense: Principal, Student & Parent Conference

2<sup>nd</sup> Offense: Principal, Student & Parent Conference & Admin.Discretion

## 16. Sexual Harassment/Sexual Assault

1<sup>st</sup> Offense: Guidance, Student & Parent Conference

2<sup>nd</sup> Offense: Principal, Counselor, Student & Parent Conference

3rd Offense: Admin. Discretion and/or Agency Referral

# 17. Other Offense: Discretion of Building Principal and/or Supervisor

## \*It is understood that any offense may be referred to the police, if deemed appropriate by the Building Principal or Superintendent.\*
